

<u>L.D. Bell High School Orchestras</u> Corpus Christí Tríp Contract

Dear Parents and Students,

It is time to make arrangements for our annual orchestra trip. This year the orchestra will be traveling to Corpus Christi, Texas.

The planned dates for the trip are: Friday, April 12 through Monday, April 15, 2019.

Trip package includes:

The total cost of the trip is \$550.00. Students will need to provide their own spending money and money for anything not listed above in the Trip Package. We will stop at an HEB grocery store where each chaperone room will be given money to spend on food which will be prepared in the condominiums. Bringing extra money for any extra snacks, souvenirs, etc. should be considered by each individual going on the trip.

We understand that the completion and submission of this document obligates the above named student to pay the full balance due, non-refundable, regardless of the student's ability to participate in the trip for any reason. Due to the booking of condominiums, transportation, and amusement activities – this is a non-refundable obligation.
